

### Editor's Note

Dear Reader,

only a few days have passed since the release of our previous issue, and we are pleased to present the second special issue of Recorder. In this special issue 2-2 for 2025, we publish a new original study devoted to the history of the second Commandery of the Masonic Order of Knights Templar in the city of Quincy, Illinois — El-Aksa Commandery No. 55. Founded in 1882, this Commandery existed alongside Beauseant Commandery No. 11 until 1911, when both Commanderies were merged under the new name Quincy Commandery No. 77.

Despite its relatively short history — only twenty-nine years — El-Aksa Commandery No. 55 left a significant mark on the history of the Masonic movement not only in Quincy but across the state. The Commandery demonstrated that even young organizations can serve as a model for older Commanderies and have a noticeable influence on shaping the traditions and structure of local Masonry.

The study is based on the annual Proceedings of the Grand Commandery of Knights Templar of the State of Illinois for the period 1882–1911. Over these nearly three decades, a total of 170 individuals were affiliated with the Commandery. Among its members were figures of regional and statewide prominence, including Civil War veteran Brigadier General Elisha Bently Hamilton (1838–1902) and Alfred A. Whipple (1845–1928),

who subsequently attained the office of Grand Commander of the Grand Commandery of Illinois.

Particular attention is drawn to the exceptional continuity in the office of Treasurer. Throughout the entire history of El-Aksa Commandery No. 55, this position was held by a single individual from 1882 until 1909. Under his long tenure, the Commandery accumulated considerable funds, which were kept in a bank at interest, providing a stable annual income that materially contributed to the organization's regular operations.

By contrast, other offices were characterized by frequent rotation. This practice appears to have been a deliberate strategy by the leadership, allowing a greater number of Sir Knights to serve in officer positions and gain administrative experience. However, frequent changes, particularly in the office of Recorder, created certain challenges for maintaining accurate membership records. Beginning in 1899, measures were undertaken to reduce turnover in this office, which helped to systematize recordkeeping and improve administration.

We hope that the history of these two Commanderies from a single city will be of interest to our readers, offering insight into the Masonic movement in Quincy at the turn of the 19th and 20th centuries and helping to provide a comprehensive view of urban Masonic life during this period.



## **History of El-Aksa Commandery No. 55, KT (Quincy, Illinois)**

### **Abstract**

The present study examines the history of El-Aksa Commandery No. 55, a Masonic body of the Knights Templar located in Quincy, Illinois. The research is based on the annual Proceedings of the Grand Commandery of Knights Templar of the State of Illinois for the period 1882–1911.

In retrospect, El-Aksa Commandery No. 55 maintained an institutional presence in the city of Quincy, Illinois, for twenty-nine years, spanning the period from 1882 to 1911. Over these nearly three decades, a total of 170 individuals were affiliated with the organization. The roster of members included several figures of regional and statewide prominence, among them Brigadier General Elisha Bently Hamilton (1838–1902), a veteran of the Civil War, and Alfred A. Whipple (1845–1928), who subsequently attained the office of Grand Commander of the Grand Commandery of Illinois. As the second commandery established in Quincy, El-Aksa No. 55 played a significant role in shaping the local Templar presence, and its officers undertook sustained efforts to secure wide recognition for the Commandery both within the city and across the state. Reports submitted by various Grand Officers of the Grand Commandery of Illinois throughout the 1880s and 1890s consistently testify to the high regard in which the Commandery was held, identifying it as one of the most active and well-managed bodies in Illinois.

One of the most striking institutional features of El-Aksa Commandery No. 55 was the exceptional continuity observed in the office of Treasurer. Throughout the entire lifespan of the Commandery, this position was held by a single individual, whose tenure extended from 1882 until his death in 1909. Under his long stewardship, the Commandery accumulated a considerable financial reserve. Deposited in a local bank at interest, these funds generated a steady annual income that materially contributed to the stability and routine functioning of the organization.

The remaining offices, by contrast, were characterized by a pronounced degree of rotation. This pattern can plausibly be interpreted as reflecting a deliberate policy on the part of the leadership to allow a larger number of Sir Knights to advance through the officer line, thereby broadening administrative experience within the membership. Yet such a practice—particularly in relation to the office of Recorder—introduced certain administrative complications. By the late 1890s, the accumulated difficulties associated with maintaining accurate membership records prompted a shift in policy, and from 1899 onward efforts were undertaken to reduce the frequency of turnover in this position.

In 1907, the Commandery reached its highest recorded membership, numbering 104 Sir Knights. Thereafter, a gradual decline ensued. At the same time, the city's older commandery, Beauseant Commandery No. 11, maintained a significantly smaller membership, estimated at approximately 60 Sir Knights. In view of the diminishing numbers and the overlapping constituencies of the two bodies, a decision was reached in 1911 to effect their consolidation. The merger was implemented the following year, resulting in the establishment of Quincy Commandery No. 77 in 1912. With this organizational restructuring, the distinct historical trajectory of El-Aksa Commandery No. 55 came to an end.

### Historical Background:

The future city of Quincy was located on the picturesque bank of the Mississippi River, a position that largely predetermined its subsequent development. Its advantageous geographical location made the area attractive to early settlers, while the river itself served as a major natural transportation artery for the region. In 1834, Quincy officially obtained the status of a city, marking the beginning of the formation of municipal institutions and a period of active urban development<sup>1</sup>.

By the 1850s, Quincy had emerged as one of the key transportation hubs of the Midwest. Important routes connecting the eastern and western parts of the United States passed through the city, making it a significant point for trade, transport, and migration. The expansion of river traffic, the construction of railroads, and the building of bridges all contributed to a rapid increase in commercial activity. New economic opportunities attracted growing numbers of settlers to the region, and Quincy gradually developed into a dynamically expanding center.

By 1880, the city's population had reached approximately 27,000 inhabitants. At that time, Quincy was for a period the second-largest city in Illinois after Chicago, reflecting its importance within the state and the broader region.

At the turn of the nineteenth and twentieth centuries, the city's transportation infrastructure continued to develop actively. Improvements in railroad connections, the modernization of river ports, and the introduction of new transportation systems facilitated a further increase in passenger traffic and the inflow of labor. In turn, this stimulated industrial expansion, urban territorial growth, and the development of social institutions—from schools and hospitals to cultural organizations.

By 1910, Quincy's population exceeded 36,000, demonstrating the city's continued upward trajectory and its strengthening role as a regional economic and cultural center.

In early 1882, a group of Knights Templar from the city of Quincy—among them Thomas Austin, Edward E. Manson, and Evelyn C. Selleck—submitted a petition for a charter to establish another commandery in the city<sup>2</sup>.

On April 13, 1882, El-Aksa Commandery was granted permission to receive the petition and to present it for consideration at the next Annual Conclave<sup>3</sup>. At the same time, the Grand Commander ordered the appointment of the following officers of the new commandery: Eminent Commander – Tomas Austin, Edward E. Manson – Generalissimo, Evelyn C. Selleck – Captain General<sup>4</sup>.

The Knights Templar chose a rather uncommon name for the commandery — El-Aksa, in honor of the ancient temple of the Knights Templar erected on Mount Moriah in Jerusalem. Charles G. Addison's *The Knights Templar*<sup>5</sup> includes an illustration of El-Aksa, which after the Crusades was converted by Muslims into a mosque. It is this general view of El-Aksa that we wish to present here (Fig. 1).

In the summer of 1882, the commandery numbered 26 members<sup>7</sup>. Thomas Austin was elected to the office of Eminent Commander, and William Evers to that of Recorder<sup>8</sup>.

On August 30, E. Sir Loyal Levi Munn, Grand Commander, personally visited the commandery and left the following account of his visit:

“August 30th, A.O. 764, I visited El-Aksa Commandery, U.D., stationed at Quincy. I arrived in the evening, as they were about to repair to the banquet hall, they having previously conferred the Illustrious Order of the Red Cross. After the banquet their commandery was open for inspection, rehearsal and review. There were present Eminent Sir O. C. Wheeler, the Grand Prelate of California; Eminent Sir Rev. F. D. Rickerson, Grand Prelate; Eminent Sir E. S. Mulliner, Grand Sword-Bearer; Eminent Preceptor E. H. Raymond, of Burleigh Preceptory, Knights Templar of Canada; and Eminent Sir John P. Norvell. The Order of the Temple was conferred upon two aspirants. This commandery starts out under very favorable auspices, and I have great hopes of its future usefulness”<sup>9</sup>.

This visit was also mentioned in the report of Grand Sword Bearer Sir Edward S. Mulliner: “It has been my privilege to visit El-Aksa Commandery, U.D., frequently since she received her dispensation. Your own recent official visit to this enthusiastic young Commandery, U.D., renders it unnecessary for me to say more than this: that in her personnel, she presents all the elements of knightly character, her officers and members created being chosen from a high grade of professional and business gentlemen; and that in respect to work,

drill, equipments, records and financial condition, she is already the peer of most of the chartered Commanderies in this Grand Jurisdiction”<sup>10</sup>.

On October 24, 1882, the Annual Conclave of the Grand Commandery of Illinois was held, and in his address the Grand Commander recommended supporting the proposal to issue a charter for El-Aksa Commandery<sup>11</sup>.

At the conclave, the Report of the Committee on Charters and Dispensations was read, noting that the committee had examined the books and documents of El-Aksa Commandery and had determined that the work of the commandery was being conducted in accordance with the Statutes and Regulations of the Grand Commandery of Illinois. In conclusion, the Committee on Charters and Dispensations recommended issuing a Charter for El-Aksa Commandery No. 55<sup>12</sup>.

The Committee on Templar Jurisprudence, having reviewed the By-Laws of El-Aksa Commandery No. 55, recommended their adoption with minor amendment<sup>13</sup>.

On the same day — October 24, 1882 — El-Aksa Commandery No. 55 was chartered<sup>14</sup>.

Organizationally, El-Aksa Commandery No. 55 was incorporated into the Sixth District, for which Grand Sword Bearer Sir E. S. Mulliner was responsible<sup>15</sup>.

In 1883, the membership of the commandery increased to 31, with 5 Created during the year<sup>16</sup>.

In 1884, the membership of the commandery increased to 39. During the year, 5 were Created and 3 were Admitted<sup>20</sup>.

On February 22, 1884, the commandery was visited for inspection by E. Sir Norman T. Gassette, Grand Standard Bearer (Fig. 2), who wrote the following account of his visit: "EL-AKSA COMMANDERY has good reasons to be proud of its record. There is not a Sir Knight in arrears for dues in the command. Of its then thirty-five members, thirty-one were fully equipped and in line on the night of the inspection; and those who were absent were prevented from being present by unavoidable circumstances. The inspection and reception was public, and was attended by a brilliant audience, made up of invited guests, and the wives, daughters and ladies of the Sir Knights.

The address of E. Sir Knight Thos. Austin was a credit to him, El-Aksa Commandery, and the Grand Commandery; and the banquet which was served after the ceremonies was all that could be desired.

E. Sir Thos. Austin, Commander, and his council, Sirs Generalissimo E. C. Selleck and Captain General Corydon S. Hickman, have cause for congratulation, and I suggest that if the Commanderies in the state, bearing numbers in the first tens numerically, are not careful, that those bearing numbers in the fifties will excel them. At the date I inspected"<sup>24</sup>.

In addition to this, in his report Norman T. Gassette described one of the commandery's events: "El-Aksa Commandery made a pilgrimage to Danville, Ill., and participated in Ascension Day services with Athelstan Commandery, of that place, whose guest it was. Of the thirty-nine Sir Knights of El-Aksa Commandery No. 55, thirty-three were in line, and "carried a most beautiful banner. It was greatly admired by everybody. A little of its history will be interesting to ladies, as it is the work of one of their sex. Mrs. Hilton, wife of Eminent Sir Knight Hilton, is the lady who executed the work. The front is composed of souvenir badges gathered from different Commanderies of the triennial conclaves since 1868. No two badges are alike. They

are artistically arranged, and fastened upon the background with a feather stitch in different colored silk. In the center of the badges is a red cross bearing the name of the Commandery. The back is crimson satin, in the center of which is a black velvet maltese cross. A remarkable circumstance, and one that was not designed, is the fact that there are just fifty five pieces in the work, and 55 is the number of the Commandery. The banner is a gift to the Commandery from Mrs. Hilton, and the members are justly proud of it." After the religious ceremonies were concluded, at 8 o'clock P. M., an elegant banquet was served in the armory of Battery "A," and "Eminent Sir" Thomas Austin, of El-Aksa Commandery No. 55, responded to the toast:

"Pilgrimage—The duty and joy of the Templar."

"He referred to this visit as an occasion for special rejoicing on the part of his Commandery. That El-Aksa Commandery had received sympathy and encouragement from Athelstan Commandery from its organization. His speech was full of beautiful thoughts, and clothed in appropriate words"<sup>25</sup>.

In 1885, the membership of the commandery declined to 37. During the year, 1 was Created and 3 were Dimitted<sup>26</sup>.

In 1886, 39 commanderies took part in the Triennial Conclave of the Grand Encampment in St. Louis. Some of them—for example, Apollo Commandery No. 1—arrived with a contingent of 128 Sir Knights, 20 ladies, and 43 members of the band<sup>34</sup>. El-Aksa Commandery No. 55 was also in attendance, represented by 30 Sir Knights<sup>35</sup>.

On November 3, 1886, the Grand Commander issued General Order No. 1, according to which El-Aksa Commandery No. 55 was transferred to the Second District (under the supervision of Sir Norman T. Gassette, Grand Generalissimo)<sup>36</sup>.

In 1887, the membership of the commandery increased to 49. During the year, 3 were Created, 2 were Admitted, and 2 were Dimitted<sup>37</sup>.

On April 28, 1887, E. Sir Norman T. Gassette, Grand Generalissimo, conducted the annual inspection of the commandery: "Thursday evening April 28th I made an inspection of El-Aksa Commandery No. 55, K. T. By virtue of your Dispensation the inspection was public. There were gathered in the Asylum many eminent Sir Knights who came from different parts of this and other Grand Jurisdictions, (among the number the two distinguished Templars who went with me to Clayton), a large number of the most prominent citizens of Quincy, and a numerous concourse of ladies. The Banquet was excellent and the whole affair was as brilliant as one would expect anything to be, under the auspices of this exceptional Commandery. Eminent Sir Thos. Austin, its first Commander, his successor Eminent Sir L. B. Boswell and Sir Knights have every reason to be proud of the Command to which they belong. The opinion is offered, that in proportion to the total membership, a larger number of correctly equipped Sir Knights will be found in line upon ordinary, or special occasions, than in any other Commandery of which we have knowledge.

The Financial Statement of the Commandery is so unusual that it is appended.

Such a statement is common from El-Aksa Commandery I presume, a similar one having been made to me two years ago when I officially visited the Commandery. The hospitality of the Commandery is generous and hearty. El-Aksa observed Easter Sunday by attending divine service at the First Congregational Church as a body”<sup>40</sup>.

On November 30, 1887, E. Sir Edward S. Mulliner, Grand Commander, visited El-Aksa Commandery No. 55, and left the following note in his report regarding this visit: “On the 30th day of November, 1887, I visited, as their guest, El-Aksa Commandery No. 55, stationed in my own city— they having tendered a complimentary reception and banquet to your Grand Commander.

It was wholly a social occasion participated in by the Sir Knights of the Commandery, their ladies and a few invited guests from abroad.

The cordial expression of personal regard and reference to local pride indulged in by the eminent Commander of this young and prosperous Commandery, in his address of welcome, were gracefully mingled with sentiments of loyalty and love to this Grand Commandery which, in its behalf, were courteously acknowledged”<sup>41</sup>.

In 1888, the membership of the commandery increased to 54. During the year, 8 were Created and 3 were Dimitted<sup>42</sup>.

On February 10, 1888, the commandery was visited by E. Sir George M. Moulton, Grand Generalissimo, who wrote the following about his visit in his report: “February 10th was the occasion of my first official visit, which was made to the Asylum of El-Aksa Commandery No. 55, K.T., L. B. Boswell, Eminent Commander. The Illustrious Order of the Red Cross was conferred during the afternoon upon a class of six Companions, among whom was the Mayor of the city. This was the last opportunity I had to witness the work of the Order according to the old Ritual, as since April 1st, all of the Commanderies in the Second District have become proficient in the Ritual adopted at St. Louis, and are loyally, although hardly contentedly, exemplifying it.

The zeal for the Order, and the love and pride for their Commandery borne by the Fraters of El Aksa is so well known, that it is unnecessary for me to say that all which they did on the occasion referred to was well done. At 7 P.M. the Commandery formed the lines, fully armed and equipped as Knights Templar. After receiving the Inspecting Officer with honors, the Commandery went through the evolutions of inspection and review in a manner highly creditable, alike to themselves and the appreciative audience of fair ladies, who had been invited to attend a banquet which had been prepared for the occasion. The pleasant features of the evening, including singing, dancing, and social conversation, made a fitting conclusion to a very successful and gratifying Conclave. El-Aksa enjoys the uncommon honor of having no delinquents on her list of members, and has had none since her organization. Its cash assets, including sinking fund and bills receivable, are almost \$1,300.00, with no liabilities. Its membership is not large, but is making a steady and desirable growth.

They are pretty generally equipped according to regulation. It may be unhesitatingly affirmed that in all save the matter of scientific drill that El-Aksa Commandery is the peer of any in the State. This Commandery attended evening services at the Congregational (Unitarian) Church in Quincy on Easter Day, at which there was a large attendance of Sir Knights”<sup>45</sup>.

On May 23, 1889, the commandery was visited by E. Sir S. O. Spring, Grand Captain General; we cite excerpts from his report on the visit: "May 23rd, in response to a request from Em. Sir H. H. Montgomery, Grand Sword Bearer, I visited El-Aksa Commandery, No. 55, stationed at Quincy. He having met with an accident which prevented him from fulfilling an engagement made for that date. The occasion being entirely of a social character no work was done and no formal inspection made, in fact the reports of the former inspecting officers were of such a character as to render it entirely unnecessary. Although not of a large membership, being comparatively a young Commandery, yet for courtesy, hospitality and the high social standing of its members it is not surpassed by any in this Grand Jurisdiction. The records of the Commandery are nicely kept, and the finances under the management of Sir Knight E. A. Rogers, Treasurer, are in excellent condition, assets aggregate about \$1,500.00 with no liabilities. The dues of the Commandery are payable semi-annually in advance, which rule should be the law in every Commandery. The Commandery being closed, the Sir Knights, their ladies and friends, which included the writer, spent a most enjoyable evening. The fraters of El-Aksa have reason to congratulate themselves that within their own membership they possess a Quartette equal to any in the land, who rendered several choice selections during the evening. The Grand Officer that inspects El-Aksa Commandery has a pleasant task, and I trust I may again have that

On May 29, 1890, an official visit to the commandery was made by E. Sir Augustus L. Webster, Grand Sword Bearer, who noted the following in his report on the visit: "May 29, made an official visit to El-Aksa Commandery, No. 55, stationed at Quincy. An inspection of the records show the Commandery to be in excellent condition. The records and system of filing papers are as complete and systematic as any which have come under my observation. In the evening a "Reception" was tendered your Inspecting officer and invited guests at the "Newcomb." A royal banquet was enjoyed, and dancing indulged in till the "wee sma' hours." Eminent Sir Wells deserves great credit for the successful manner in which every detail was carried out. I can only reiterate the mooted words of praise bestowed upon El-Aksa, her officers and Sir Knights by former Inspectors. She is worthy the high place she occupies among the live Commanderies of Illinois. My visit to El-Aksa was made at the request of Very Eminent Sir Jos. E. Dyas, Deputy Grand Commander, in whose district it was. At his request I consented to visit El-Aksa and Galesburg, No. 8, in exchange for Bethany, No. 28, and Sterling, No. 57, it being inconvenient for him to visit those two Commanderies"<sup>55</sup>.

In addition, the members of the commandery accompanied the Grand Officers during inspections of other commanderies. For example, on March 17, 1890, E. Sir S. O. Spring, Grand Generalissimo, visited Ascalon Commandery No. 49; during this visit he was accompanied by 15 Sir Knights from El-Aksa Commandery, led by Eminent Commander G. Wells<sup>56</sup>.

Pace, Grand Standard Bearer, who recorded his impressions of the visit in his official report as follows: "It goes without saying that the fratres of El Aksa and their ladies entertain well. On this occasion, if possible, they succeeded beyond their custom in ministering to the pleasure of their guests.

The charter members of El Aksa Commandery at the time of its organization erected a very high standard of excellence in respect to character of membership, social courtesies, ritualistic work, style of record, and management of its financial affairs, which has been steadily maintained, so that Inspecting Officers from year to year have been wont to refer to this Commandery as a sort of model.

I am pleased to say that I believe it has been unusually prosperous during the last few months under the command of Eminent Sir Konantz.

The present membership is seventy, all uniformed, but not so proficient in tactics and the manual as in years past.

In the 1906 Proceedings, a biography of the most distinguished Templar associated with El-Aksa Commandery No. 55 was published in full. It reads as follows: "ALFRED AUGUSTUS WHIPPLE.

Closely allied to the principles upon which is based the Brotherhood of Freemasonry—charity, unselfishness, the fraternal relationship between men, and a confidence in the good and mercy of a Supreme Being—are the qualities necessary to the successful practice of the medical profession. Brought daily face to face with the sterner side of life in constant juxtaposition with sickness and suffering, the physician must possess a character consistent with the duties inseparable from his life and whose predominating attribute must necessarily be a generous consideration for his fellow men. For nearly one-third of a century Dr. Whipple has followed the noble calling which in his youth he determined to devote his future career, and that he has succeeded in his laudable ambition is amply attested by his present honorable standing in the medical world; and now, in the prime of life, he can look back upon the unrecalable past with a calm sense of having conscientiously performed his duty to his God and to humanity in general.

Brother Whipple's connection with the Masonic fraternity dates back thirty-eight years. Appreciating the fact that by becoming associated with a society which had for its object the mental and moral elevation of the human race, he would be more fully equipped for the exigencies of his profession, he applied for admission in Cattaraugus Lodge No. 239, and after receiving the first two degrees was raised to the sublime degree of Master Mason on May 30, 1868. He received the Capitular degrees in Olean Chapter No. 150, New York, May 12, 1871, and was Principal Sojourner soon after in Salamanca Chapter U.D., R.A.M. Subsequently he removed to Quincy, Ill., and affiliated with Quincy Lodge No. 296, A.F. and A.M., and Quincy Chapter No. 5, R.A.M. He has served in the East in both above named bodies. He is a member of Quincy Council, R. & S. M., in which he served as Thrice Illustrious Master. On August 30, 1882, he was admitted a Companion of the Illustrious Order of the Red Cross in El-Aksa Commandery No. 55 at Quincy, and was created a Knight Templar therein the 14th of September following. In this latter body he served as Eminent Commander in 1897–98, after having filled many of the subordinate official positions therein.

In the Scottish Rite, Dr. Whipple attained to the ineffable degree of Sublime Prince of the Royal Secret in Quincy Consistory, January 19, 1887, and was subsequently elected Commander-in-Chief, serving in that capacity during the years of 1893, 1894 and 1895.

At the session of the Supreme Council held in Providence, R. I., September, 1902, he was elected to receive the Thirty-third and last degree of the A.A. Scottish Rite, and the same was conferred on him at the annual session of the Supreme Council held in Boston, September 15, 1903.

His earnest zeal and great activity in the interests of the Masonic fraternity soon made him prominent in our Grand Bodies and caused his promotion to office in Grand Chapter as Grand Master of the First Veil in 1893, and Grand Sword Bearer in the Grand Commandery K.T. of Illinois in 1899. Having been promoted through the line of official chairs in both bodies, he was elected Deputy Grand High Priest, October 24, 1901, and in a few weeks he was, through the lamentable death of Grand High Priest Charles H. Patton, called to fill his position. The duties of Acting Grand High Priest were so well performed by him that he received the highest gift in the Grand Chapter by being elected Grand High Priest October 30, 1902, and Grand Commander Knights Templar of Illinois October 24, 1905, presiding as Grand Commander at the Semi-Centennial Conclave, October 23 and 24, 1906.

R. E. Sir Whipple was born in the town of Mansfield, Cattaraugus county, N. Y., October 31, 1845, and was educated in the public schools until the breaking out of the civil war, when his father enlisted in the Union army, leaving to him the care and support of his mother and five younger children. By the fortunes of war his father never returned, having been taken prisoner at Gettysburg, Pa., July 1, 1863, and died at Andersonville, Ga., a little over a year later, and it was long after the close of the war before his family knew anything of him more than that he was in some Confederate prison or had passed beyond the reach of suffering.

He was married October 6, 1869, at Salamanca, N. Y., to Miss Lydia E. Learned (daughter of Dr. Henry Learned), who in every sense of the word has been a help-mate and mother of five children, four sons and one daughter, the daughter dying in 1876 at the age of four years.

He studied medicine with his father-in-law at Salamanca, and after a three-years course graduated from the Eclectic Medical Institute of Cincinnati, Ohio, in 1876. After a few years of practice at Randolph, Cattaraugus county, and Cuba, Allegany county, N. Y., he entered Hahnemann Medical College and hospital of Chicago, Ill., for post-graduate course, receiving his degree from that institution in March, 1880, and in April of that year located at Quincy, Ill., where he has since been in active practice<sup>123</sup>.

On 27 April 1910, E. Sir John Durham Cleveland issued Special Orders No. 5, appointing E. Sir William H. McMein, Recorder of El-Aksa Commandery No. 55, as Special Inspector for the inspection of Ascalon Commandery No. 49 on 17 May 1910<sup>149</sup>.

In 1911, the membership of the Commandery declined to 90. During that year, 1 Dimitted<sup>150</sup>.  
The list of officers for the Commandery was not published in 1911.  
Dimitted: James Worth Wayland<sup>151</sup>.

In 1911, the members of El Aksa Commandery No. 55 and Beauseant Commandery No. 11 submitted a petition to merge the two commanderies in the city of Quincy. The petition specifically noted: «REPORT—Committee on Charters and Dispensations.

Sir Knight Holman G. Purinton, P.G.C., submitted the report of the Committee on Charters and Dispensations. It was adopted.

To the Grand Commandery of Knights Templar of Illinois:

Your Committee on Charters and Dispensations has had placed before it for its consideration a petition for a charter for a Commandery to be located at Quincy, Illinois, to be known as Quincy Commandery. It is in regular form and signed by 135 Sir Knights, of whom fifty are members of Beauseant Commandery No. 11, and eighty-one are members of El-Aksa Commandery No. 55, and four dimitted Sir Knights. Accompanying this petition are four dimits and 131 receipts for dues, and conditional dimits for same. The petition is in pursuance of a proposed consolidation of the two Commanderies mentioned, both of which are located at Quincy, Illinois, all of which is set forth in duly authenticated copies of resolutions adopted by said Commanderies agreeing to surrender the charters now held by them, and to turn over all property and obligations now held by them to the new Commandery. After carefully considering this petition we recommend:

First — That a charter for a Commandery be granted the petitioners, to be known as Quincy Commandery No. 77.

Second — That in view of the fact that Beauseant Commandery No. 11 and El-Aksa Commandery No. 55 each having previously paid their charter fees, that the charter fee for the new Commandery be remitted.

Third — That the properties and obligations of the existing Commanderies be vested in and assumed by Quincy Commandery, and

Fourth — That the surrender of the charters of Beauseant Commandery No. 11 and El-Aksa Commandery No. 55, and the transfer of their properties take place at the time Quincy Commandery No. 77 is constituted»<sup>152</sup>.

In 1912, neither El Aksa Commandery No. 55 nor Beauseant Commandery No. 11 existed in the Grand Commandery of Illinois; instead, Quincy Commandery No. 77 was established, with a total of 134 Knights<sup>153</sup>.

In Table 1, we compiled data on the members of El-Aksa Commandery No. 55 for the period from 1882 to 1911, indicating changes in their status within the commandery. If no entry follows the date of joining the commandery, it means that the Knight continued to serve as of 1911.

According to the data presented in Table 1, a total of 170 individuals were affiliated with El-Aksa Commandery No. 55 over the period from 1882 to 1911. It was not uncommon for Masons to join the Commandery as entire families. For example, the Osborn and Smith families each had four members in the Commandery, while the Miller, McMein, and Gardner families each had three members.

By 1911, many of the organization's senior members were still active, reflecting the fact that the Commandery had been established only twenty-nine years earlier. Among these long-standing members were Alfred Augustus Whipple, David Franklin Wilcox, and others who had been admitted as early as 1882. The oldest deceased member of the organization was Benoni Mendenhall, who was born in 1827.

Statistical data on membership changes over the 29-year period are presented in Table 4.

An analysis of Table 2 reveals a slight discrepancy when compared with Table 1. In Table 1, 170 names are recorded, whereas in Table 2 the columns for Created and Admitted include 175 names. This difference appears to result from two distinct types of errors in the membership records.

The first type of error involves duplication of the same information across different years. For example, Henry John Smith is reported as having joined the Commandery twice, in 1884 and again in 1886. The second type of error concerns the inclusion of Dimitted members within the Admitted category upon their reinstatement, rather than listing them under Reinstated. By contrast, membership records for Bethany

Commandery No. 28<sup>154</sup> and Beauseant Commandery No. 11<sup>155</sup> did not follow this practice. Such recording practices led to duplications in the data for admitted members. According to Table 1, examples of this phenomenon include Corydon Sheldon Hickman, Otto Adolph Mohrenstecher, Harvey Chatten, and Lewis Benjamin Boswell. Taken together, these five names account for the discrepancy between Table 2 and Table 1.

Table 2 enabled the compilation of data suitable for visualizing the membership of El-Aksa Commandery No. 55 over the period from 1882 to 1911. For convenience, these data have been represented in Chart 1.

**Chart 1.** Membership of El-Aksa Commandery No. 55, 1882–1911




Chart 1 illustrates that throughout nearly the entire period of its existence, El-Aksa Commandery No. 55 experienced active growth, reaching a membership threshold of over 100 Sir Knights in 1907. Notably, there was no significant decline in the size of the Commandery during its years of operation.

We also present brief biographical data for members of El-Aksa Commandery No. 55 who remained affiliated with the organization at the time of their deaths. This list is arranged in alphabetical order.

#### Adams, John Quincy (1845 – Nov. 9, 1892)

John Quincy Adams was born in 1845, in Quincy, Adams County, Illinois.

He was married to Mary Josephine Homan.

A veteran of the Civil War, he served in the 10th Illinois Infantry with the rank of Private. Adams joined El-Aksa Commandery No. 55 in 1882 as one of its founding members. In 1883, he was elected to the office of Captain of the Guards. He did not hold any other officer positions.

He died on November 9, 1892.

Baker, Calot Ezekiel (Apr. 21, 1844 – Sep. 6, 1903)


Carlott Eyskill Baker was born on April 21, 1844, in Troy, New York.

He was married to Georgia Berry.

A veteran of the Civil War, he served in the 5th Kentucky Infantry Regiment with the rank of Colonel.

He joined El-Aksa Commandery No. 55 in 1886. He did not hold any officer positions.

He died on May 6, 1895.

Bishop, James Melville (Jun. 24, 1835 – Mar. 14, 1892)



James Melville Bishop was born June 24, 1835, in Readfield, Kennebec County, Maine.

He was married to Elizabeth Noble Bishop.

He joined El-Aksa Commandery No. 55 in 1888. In 1889, he was elected to the office of Warder. He did not hold any other officer positions.

He died on March 14, 1892.

Brewster, William Morris (Oct. 17, 1854 – Mar. 3, 1903)

William Morris Brewster was born on October 17, 1854, in Norwalk, Ohio.

He was married to Lillie Brewster.

He joined El-Aksa Commandery No. 55 in 1892. He did not hold any officer positions.

He died on March 3, 1903.

Cadogan, William Henry (Jan. 27, 1855 – Sep. 9, 1892)


William Henry Cadogan was born January 27, 1855, in Quincy, Adams County, Illinois.

He died on January 21, 1906.

Epperson, James Dallas (1846 – Apr. 19, 1906)

James Dallas Epperson was born in 1846, in Indiana.

He was married to Lydia Epperson.

He joined El-Aksa Commandery No. 55 in 1887. He did not hold any officer positions.

He died on April 19, 1906.

Dr. Gardner, Robert Adams (Sep. 1, 1861 – Jun. 17, 1908)



Robert Adams Gardner was born on September 1, 1861, in Battle Creek, Calhoun, Michigan.

He was married to Mamie Emma Oertle.

He joined El-Aksa Commandery No. 55 in 1891. In 1895, he was elected to the office of Standard Bearer. He did not hold any other officer positions.

He died on June 17, 1908.

Gen. Hamilton, Elisha Bently (Oct. 5, 1838 – Mar. 20, 1902)



Elisha Bently Hamilton was born on October 5, 1838, in Carthage, Hancock County, Illinois.

He was married to Mary Emma Hamilton.

A veteran of the Civil War, he served in the 118th Illinois Volunteer Infantry with the rank of 1st Lieutenant and concluded his military service with the rank of Brigade General.

He joined El-Aksa Commandery No. 55 in 1897. In 1898, he was elected to the office of Sword Bearer. He did not hold any other officer positions.

He died on March 20, 1902.

Marshall, James William (Dec. 28, 1842 – Apr. 14, 1907)

James William Marshall was born on December 28, 1842, in Cass, Illinois.  
He was married to Saloma Anna Colpetzer.  
He joined El-Aksa Commandery No. 55 in 1888. He did not hold any officer positions.

He dead on April 27, 1907.


Meyer, Frederick William (Dec. 9, 1836 – Aug. 13, 1899)

Dr. Moore, Frederick Porter (Sep. 22, 1853 – Jan. 20, 1889)

Frederick Porter Moore was born on September 22, 1853, in Hume, Allegany County, New York.  
He was married to Alice Medora Rogers.  
He joined El-Aksa Commandery No. 55 in 1883. He did not hold any officer positions.  
He dead on January 20, 1889.

Newcomb, Richard Foote (Sep. 20, 1837 – May 15, 1904)



Richard Foote Newcomb was born on September 20, 1837, in Bernardston, Franklin County, Massachusetts.

He was married to Eliza Ann Bowman.

He joined El-Aksa Commandery No. 55 in 1882 and was one of its founding members. He did not hold any officer positions.

He died on May 15, 1904.

Notter, John George (Dec. 1849 – Dec. 13, 1907)

John George Notter was born in 1849, in Quincy, Adams County, Illinois.

He was married to Emma A. Schultheis.

He joined El-Aksa Commandery No. 55 in 1889. He did not hold any officer positions.

He died on December 13, 1907.

Porter, Benjamin Franklin (Jan. 8, 1859 – Jun. 22, 1905)

Benjamin Franklin Porter was born on January 8, 1859, in Canton, Fulton County, Illinois.

He was married to Anna B. Porter.

He joined El-Aksa Commandery No. 55 in 1899. He did not hold any officer positions.

He died on June 22, 1905.

Rogers, Edward Alpheus (Aug. 2, 1845 – Nov. 1, 1909)


Edward Alpheus Rogers was born on August 2, 1845, in Quincy, Adams, Illinois.

He was married to Ellenora Payne Rogers.

He joined El-Aksa Commandery No. 55 in 1882 as one of its founding members. In 1883, he was elected to the office of Treasurer, a position he held for more than twenty-five years until his death.

He died on November 1, 1909.

Dr. Smith, Henry John (Mar. 17, 1840 – May 12, 1892)



Henry John Smith was born on Mar. 17, 1840, Huntington, Huntington County, Pennsylvania. He was married to Cornelia Keyes. He joined El-Aksa Commandery No. 55 in 1884. He did not hold any officer positions. He died on May 12, 1892.

Smith, James Russell (Feb. 10, 1847 – Mar. 9, 1894)



James Russell Smith was born on February 10, 1847, in Jacksonville, Morgan County, Illinois. He was married to Ella Wells. He joined El-Aksa Commandery No. 55 in 1889. He did not hold any officer positions. He died on March 9, 1894.

## Smith, Merry Walker (May 5, 1833 – Dec. 20, 1906)

He was born on May 5, 1833, in Adams, La Salle, Illinois.

He was married to Ann Eliza Watson.

He joined El-Aksa Commandery No. 55 in 1882 as one of its founding members. In 1883, he was elected to the office of Standard Bearer and remained in this position through 1886.

He died on December 20, 1906.

## Todd, Edson Henry (Jul. 2, 1842 – Jun. 28, 1893)

Edson Henry Todd was born on July 2, 1842, in Agawam, Hampden County, Massachusetts.

A veteran of the Civil War, he served in the 46th Infantry Regiment with the rank of 1st Sergeant.

He joined El-Aksa Commandery No. 55 in 1891. In 1892, he was elected to the office of Standard Bearer. He did not hold any other officer positions.

He died on June 28, 1893.

Wilcox, Chester Arnold (Allen) (Nov. 8, 1847 – Jul. 20, 1899)  
(Past Commander)

Chester Arnold Wilcox was born on November 8, 1847, in Harford Mills, Cortland County, New York.

He joined El-Aksa Commandery No. 55 in 1889. In the same year, he was elected to the office of Recorder and continued in this position through 1890. In 1892, he served as Prelate. In 1894 and 1895, he was elected to the highest office of Commander. From 1896, he held the title of Past Commander. In 1897, he was again elected to the office of Recorder.

He died on July 20, 1899.

In total, the list comprises twenty-four brief biographies, including one of a Templar who held the status of Past Commander. Among these members, the most prominent was Civil War veteran Brigadier General Elisha Bently Hamilton (1838–1902). Overall, among the deceased members of the Commandery, there were seven Civil War veterans, representing approximately 30% of the membership in this category.

Information regarding the officer corps of El-Aksa Commandery No. 55 is of particular importance for this study. These data have been compiled and are presented in Tables 3–5.

The data presented in Table 3 indicate that frequent rotation occurred among this group of officers. In contrast, the office of Commander was often held for two or more consecutive years.

Table 4 demonstrates that within this group of officers, only the office of Treasurer exhibited notable continuity. El-Aksa Commandery No. 55 provides a particularly unique example in this regard, as the Treasurer's office remained unchanged throughout the Commandery's entire twenty-nine-year existence.

By comparison, occupants of the other offices were subject to almost constant turnover. It was not until 1899 that the Commandery made a concerted effort to appoint a permanent Recorder—Frank Stobie Wood—in order to streamline administrative recordkeeping. Even he experienced a hiatus in 1907–1908, owing to his assumption of the highest office of Commander in 1908.

The data presented in Table 5 indicate that frequent rotation was typical among this group of officers, with personnel rarely remaining in the same office for an extended period.

For the convenience of working with the history of El-Aksa Commandery No. 55, this study also includes a list of all Eminent Commanders, arranged in chronological order.

Over the twenty-nine years of the Commandery's existence, a total of fifteen individuals served as Eminent Commander. The majority of these, eleven in total, held the office for two or more years, while four served for a single year only.

During the research for the history of El-Aksa Commandery No. 55, only two photographs of Knights Templar from the city of Quincy were discovered. The first photograph depicts Past Commander of El-Aksa Commandery No. 55, E. Sir Alfred A. Whipple, who in 1906 became Grand Commander of the Grand Commandery of Illinois. His photograph was selected for the cover of this special issue of the Recorder journal. Typically, the cover features images of individuals who, at various times, held the office of Recorder; however, Alfred A. Whipple never occupied that position. Among the nine individuals who served as Recorder in El-Aksa Commandery No. 55 between 1882 and 1911, no photographs have been located.

The second photograph pertains to Quincy Commandery No. 77, whose members participated in the annual parade during the Grand Conclave of the Grand Commandery of Illinois in 1930 (Fig. 4).

In Fig. 4, the Knights Templar are depicted wearing the official White uniform, consisting of the Dress Coat, Sash, Belt, Sword, Gloves, and Chapeau. Only a single insignia is visible on the chest.

Using methods of historical reconstruction, The Museum of the History of the American Knights Templar at Cherkas Global University has recreated the uniform of a Knight from El-Aksa Commandery No. 55 (Figs. 5–8).

In conclusion, it should be noted that El-Aksa Commandery No. 55 maintained an institutional presence in the city of Quincy, Illinois, for twenty-nine years, spanning the period from 1882 to 1911. Over these nearly three decades, a total of 170 individuals were affiliated with the organization. The roster of members included several figures of regional and statewide prominence, among them Brigadier General Elisha Bently Hamilton (1838–1902), a veteran of the Civil War, and Alfred A. Whipple (1845–1928), who subsequently attained the office of Grand Commander of the Grand Commandery of Illinois. As the second commandery established in Quincy, El-Aksa No. 55 played a significant role in shaping the local Templar presence, and its officers undertook sustained efforts to secure wide recognition for the Commandery both within the city and across the state. Reports submitted by various Grand Officers of the Grand Commandery of Illinois throughout the 1880s and 1890s consistently testify to the high regard in which the Commandery was held, identifying it as one of the most active and well-managed bodies in Illinois.

One of the most striking institutional features of El-Aksa Commandery No. 55 was the exceptional continuity observed in the office of Treasurer. Throughout the entire lifespan of the Commandery, this position was held by a single individual, whose tenure extended from 1882 until his death in 1909. Under his long stewardship, the Commandery accumulated a considerable financial reserve. Deposited in a local bank at interest, these funds generated a steady annual income that materially contributed to the stability and routine functioning of the organization.

The remaining offices, by contrast, were characterized by a pronounced degree of rotation. This pattern can plausibly be interpreted as reflecting a deliberate policy on the part of the leadership to allow a larger number of Sir Knights to advance through the officer line, thereby broadening administrative experience within the membership. Yet such a practice—particularly in relation to the office of Recorder—introduced certain administrative complications. By the late 1890s, the accumulated difficulties associated with maintaining accurate membership records prompted a shift in policy, and from 1899 onward efforts were undertaken to reduce the frequency of turnover in this position.

In 1907, the Commandery reached its highest recorded membership, numbering 104 Sir Knights. Thereafter, a gradual decline ensued. At the same time, the city's older commandery, Beauseant Commandery No. 11, maintained a significantly smaller membership, estimated at approximately 60 Sir Knights. In view of the diminishing numbers and the overlapping constituencies of the two bodies, a decision was reached in 1911 to effect their consolidation. The merger was implemented the following year, resulting in the establishment of Quincy Commandery No. 77 in 1912. With this organizational restructuring, the distinct historical trajectory of El-Aksa Commandery No. 55 came to an end.
