

During this period, more than 270 men passed through its ranks; several held officer positions in the Grand Commandery of Illinois, and one of them, Edward Starr Mulliner, became Grand Commander in 1887. Among the commandery’s notable members was Brigadier General George Valentine Rutherford (1830–1876), a veteran of the Civil War and an eyewitness to the assassination of President Abraham Lincoln.

The study offers considerable genealogical value, presenting concise biographical sketches of sixty Masons who remained members of Beauseant Commandery No. 11 until their deaths, as well as a complete roster of the commandery with notes on changes in member status over time. As such, the work will be of interest to a wide audience concerned with the history of Freemasonry in the United States.



History of Beauseant Commandery No. 11, KT (Quincy, Illinois)

Abstract

The present study examines the history of Beauseant Commandery No. 11, a Masonic body of the Knights Templar located in Quincy, Illinois. The research is based on the annual Proceedings of the Grand Commandery of Knights Templar of the State of Illinois for the period 1861–1911.

In the conclusion, the author emphasizes that Beauseant Commandery No. 11 operated in Quincy for fifty years, from 1861 to 1911. During this time, no fewer than 279 individuals became affiliated with the commandery. Among them were several notable figures, including Brigadier General George Valentine Rutherford (1830–1876), a Civil War veteran and eyewitness to the assassination of President Abraham Lincoln. A number of Past Commanders of Beauseant Commandery also held officer positions within the Grand Commandery of Illinois, and in 1887, Past Commander Edward Starr Mulliner was elected Grand Commander.

Throughout its existence, the commandery experienced both periods of rapid development and phases of decline. Significant membership growth occurred during the first fifteen years, and by 1876, the commandery numbered 113 members. Subsequently, due to a variety of factors, membership stagnated and began to fall. Contributing causes included the establishment in 1882 of El Aksa Commandery No. 55 in the same city; the insufficiently developed network of local Chapters, which served as the principal source of new members for the Knights Templar; as well as additional contributing circumstances. As a result, by 1901, only one-third of the former membership remained—44 members.

A renewed period of growth began after 1901. In 1911, the members of Beauseant Commandery No. 11 and El Aksa Commandery No. 55, both located in Quincy, decided to unite and submitted a petition to that effect to the Grand Commandery of Illinois. As a result, in 1912 a new Knights Templar body—Quincy Commandery No. 77—was established in the city. With its creation, the history of Beauseant Commandery No. 11 came to a close.

Historical Background:

The future city of Quincy was located on the Mississippi River. Quincy was granted city status in 1834. In the 1850s, the city prospered thanks to steamboat and railroad connections that linked the eastern and western parts of the United States. This led to a sharp increase in commercial activity and attracted new residents. As a result, over a period of twenty years, from 1850 to 1870, the population more than tripled—from 7,000 to 24,000 inhabitants.

During the Civil War, the city served as a center for organizing volunteer infantry regiments. In the late nineteenth and early twentieth centuries, further development of transportation infrastructure contributed to an increase in passenger traffic through Quincy. By 1910, the city's population had exceeded 36,000.

In early 1861, an initiative group of five Knights Templar from the city of Quincy, Illinois, submitted a petition to the Grand Commander of the Grand Commandery of Knights Templar of the State of Illinois requesting authorization to establish a commandery in the city. The petition was supported by a letter of

recommendation from Galesburg Commandery No. 8. The initiative group consisted of Josiah Hunt, William E. Oven, Robert E. Goodrich, John Mellen, and William Foley.

On 5 February 1861, Grand Commander Hosmer A. Johnson granted permission to establish a Knights Templar commandery in Quincy. Sir Josiah Hunt was appointed Eminent Commander, Sir W. E. Oven—Generalissimo, and Sir R. E. Goodrich—Captain General.




Fig. 1. Beauseant — the war banner of the Knights Templar²

The Knights Templar named their commandery Beauseant. The term Beauseant (also spelled baucent, baussant, etc.) was the name of the war banner (vexillum belli) used by the medieval Templars in the twelfth and thirteenth centuries. In Charles G. Addison’s well-known work *The Knights Templar*¹ an illustration of the Beauseant is also provided, which we would like to reproduce here (Fig. 1). In the American Masonic Order of the Knights Templar, several commanderies bore this name, all of them located in different states.

In the spring of 1861, an additional twelve Knights joined the commandery (Asa W. Blakesley, Charles W. Mead, Harrison Dills, William M. Avise, Damon Hanser, Roswell D. Grant, Michael McVey, John McGinnis, Jr., James Lowe, Horace S. Town, Thomas Neal, and David H. Winton). As a result, by the summer, it became possible to fill all officer positions and to retain several members without office.

Thus, in the summer of 1861, the commandery had 17 members.

On 22 October 1861, the 5th Annual Conclave of the Grand Commandery of Knights Templar of the State of Illinois commenced in the city of Chicago. Among the Visitors attending this conclave was Sir William E. Oven, who represented Beauseant Commandery³. At the conclave, reports were presented regarding the submission of the required documents by the new commanderies, and on 23 October 1861 the commandery was chartered, receiving the name Beauseant Commandery No. 11, KT⁴.

For the annual reporting, the commandery was required to submit information on changes in its membership during the summer in accordance with Table 1. This table included data on those Created, Admitted, Dimitted, Suspended, Reinstated, and Deceased.

On 6 November 1876, Sir Charles M. Morse, Grand Captain General, conducted an inspection of Beauseant Commandery No. 11. In his report regarding Beauseant Commandery No. 11, Charles M. Morse noted: «...Beauseant, No. 11. — Of this Commandery I can repeat from last year's report, "One of the best Commanderies in the State, has had a prosperous year," and "the officers well posted in their duties."»

Since my visit the Commander has been much absent from the State, but with so many illustrious Past Commanders, Beauseant will continue "a shining light."»¹.

In 1877, the commandery's membership decreased to 108 members. During the year, one Knight was Created, one Dimitted, one Suspended, one Expelled, and three Deceased².

The commandery also took an active part in the legislative activities of the relevant committees of the Grand Commandery of Illinois. Thus, on 10 December 1877, a letter was sent from George W. Wood, Recorder, to Gil. W. Barnard, Grand Recorder, with the following content:

«ASYLUM OF BEAUSEANT COMMANDERY, No. 11, K. T.,
Quincy, Ill., December 10, 1877.

Sir Gil. W. Barnard, Grand Recorder of the Grand Commandery of K. T. Ill., Chicago:

DEAR SIR AND SIR KNIGHT: At a Stated Conclave of Beauseant Commandery, No. 11, K. T., Nov. 30th last, the following resolution was offered and declared adopted by a majority of the Sir Knights present voting in the affirmative:

"That our Recorder be directed to communicate with the Grand Recorder, that while Beauseant Commandery, No. 11, K. T., recognizes the wisdom of the committee appointed by the Grand Commandery at its Annual Conclave in 1876, and who reported at the Annual Conclave in 1877 a code of By-Laws for the government of all Subordinate Commanderies in the State of Illinois, and while Beauseant Commandery holds itself loyal to all laws and edicts of the Grand Commandery consistent with the ancient statutes and regulations of our Order, it must, consistent with its own dig nity, decline to accept the code as presented as the code of By-Laws governing our Commandery, considering the same in principle a usurpation of the rights of Subordinate Commanderies which is guaranteed by their charter and the customs of the order.

On 21 January 1878, the commandery, under the signature of George W. Wood, Recorder, sent invitations to its members for the Regular Conclave scheduled for 25 January. The invitations were printed on a folded card, one copy of which is currently preserved in the Archive of Cherkas Global University. The

- New By-Laws, etc.




Fig. 2. Exterior side of the invitation¹




Fig. 3. Interior side of the invitation¹

On 10 November 1879, Sir Charles M. Morse, Grand Commander, issued General Order No. 1 regarding the creation of new districts. In this General Order No. 1, it was noted, in particular:

The Commanderies will be under the immediate supervision of the District Inspectors, as designated, and it is ordered that official inspection be made at least once during the Templar year.

The Grand Officers are also hereby ordered to make report of their doings, with such recommendations as they may deem advisable and necessary, on or before the first day of October next.

On 18 May 1880, another member of Beauseant Commandery No. 11 assumed an officer position in the Grand Commandery—Rev. Freeman D. Rickerson, who took office as Grand Prelate. This appointment occurred under the following circumstances: «...To Reverend and Eminent Sir Freeman D. Rickerson, Past Commander of Beauseant Commandery, No. 11, K. T., and now of Springfield, Ill.:

WHEREAS, Rev. Clinton Locke has been appointed V. E. Grand Prelate of the Grand Encampment of Knights Templar of the United States of America, and

WHEREAS, He has tendered his resignation as Prelate of the Grand Commandery of Illinois, to which office he was elected and installed on the 28th day of October last; now therefore, by the power in me vested, and confiding in your piety, discretion and zeal, I do hereby appoint you Grand Prelate of the Grand Commandery of Knights Templar of Illinois.

Given under my hand and seal, this 18th day of May, A. D. 1880, A. O. 762.

In 1881, Rev. Sir Freeman D. Rickerson was elected Grand Prelate of the Grand Commandery of Illinois¹.

The downward trend in the commandery's membership was associated with internal disagreements within the commandery. This was noted in his report by Edward S. Mulliner, Grand Warder, who was a member of Beauseant Commandery No. 11:

«EIGHTH DISTRICT.

Right Eminent Sir John C. Smith, Grand Commander of Knights Templar, State of Illinois.

RIGHT EMINENT SIR: — In conformity with regulations of the Grand Commandery and your General Order No. 1, I have the honor to submit my report as inspector of the Eighth Templar District, comprising Galesburg, Beauseant, Almoner, Delta and Ascalon Commanderies.

...
Beauseant, No. 11.

On the 30th day of September, by special invitation, I visited, officially, my home Commandery. Owing to the inclemency of the weather, but few Sir Knights were assembled. The Commandery was opened in form by Eminent Sir Thomas White, Eminent Commander, who has labored assiduously since his incumbancy to perfect his officers in the opening and closing ceremonies of the Asylum.

Beauseant Commandery is deficient in drill, and in the regular attendance of its officers and members; but its indefatigable Commander rigidly enforces the formal opening of his Commandery at all its conclaves, and in this respect Beauseant bears the palm in the Eighth District.

The books and records are neatly and correctly written up, and indeed Sir Knight Evers as a Recorder is a model of neatness and accuracy.

This Commandery has had no work since last winter, but now occupying her new and beautiful Asylum, is prepared to confer the Orders in a very imposing manner. It is to be regretted that some differences have arisen within the Asylum during the year, but it is earnestly hoped that time, and the exercise of a knightly tolerance of adverse opinions, will eventually bring the Commandery together upon that harmonious plane where there shall only exist a noble contention as to who shall best work and best agree.

The report also included information on the potential membership of Charter No. 5 (Quincy) and Charter No. 157 (Mendon), which were located within the area of Beauseant Commandery No. 11 and could serve as a source for recruiting new members into the commandery. According to the report, Charter No. 5 had 120

members, and Charter No. 157 had 24 members. In total, the Beauseant Commandery No. 11 area encompassed 144 charter members¹. If the total number of charter members is divided by the total membership of the commandery, the resulting value is 1.6, meaning that for each Knight, there were approximately 1.6 charter members. This ratio was the lowest compared to the other four commanderies inspected by the Grand Warder. For example, in the area of Ascalon Commandery No. 49, this ratio was 5.9; in Almoner Commandery No. 32, it was 4.7; and in Galesburg Commandery No. 8, it was 3.4².

This circumstance helps explain the trend of declining membership in the commandery in recent years: the source for replenishing the commandery was relatively weak, and no additional members could be drawn from outside.

In 1882, Rev. Sir Freeman D. Rickerson continued to hold the officer position of Grand Prelate of the Grand Commandery of Illinois⁷.

In the same year, Edward S. Mulliner held the officer position of Grand Standard Bearer⁸.

On 20 October 1882, Grand Sword Bearer Edward S. Mulliner visited Beauseant Commandery No. 11 and, in his report, provided the following description: «My home Commandery — Beauseant, No. 11 — with which I meet at nearly all her conclaves, is prosperous, harmonious and conservative, doing as much work as is consistent with a conscientious control of the ballot, which is habitually cast with scrupulous care. Her Eminent Commander, with that indomitable energy and will peculiar to Scotia's sons, presides over and directs her destinies with untiring zeal and faithful devotion.

This Commandery has considerable work now at hand, and her officers are well qualified for conferring the Orders. In the matter of drill and equipments she is hardly up to the standard, as is the case with many, if not most, of the older Commanderies. Financial condition healthy»⁹.

In 1882, at the annual Conclave of the Grand Commandery of Illinois, objections submitted by members of Beauseant Commandery No. 11 were considered, and amendments to certain legal articles in the By-Laws were adopted¹⁰.

In the same year, El Aksa Commandery No. 55 was chartered in Quincy¹¹.

The establishment of this commandery soon had a negative impact on the membership of Beauseant Commandery No. 11.

The committee have had the By-Laws of Beauseant Commandery, No. 11, under consideration, and would report that while we are not prepared to say that there is anything utterly inconsistent to the statutes and regulations of this Grand Commandery or the constitution and edicts of the Grand Encampment, still we believe that the By-Laws as laid down by the Standard By-Laws in Sec. 1, Art. 8, page 151, proceedings of 1882, on Discipline, is far better than the substitute proposed as Article 8, and therefore cannot recommend its adoption.

The balance of the By-Laws are in accordance with the statutes, and we recommend that they be approved.

Isaac N. Farrar was a Past Commander, and in his memory, an obituary was published in the proceedings of the subsequent Conclave: «EM. SIR ISAAC N. FARRAR,

Past Commander of Beauseant Commandery No. 11, died at his home in Quincy, August 7, 1880, at the age of 53 years, after a protracted illness.

E. Sir Farrar was made a Master Mason in Luce Lodge No. 439, which body he afterwards served as Master. He was also honored in Quincy Chapter No. 5, R. A. M., by being elected to the office of Secretary for ten successive years—a position he was holding at the time of his demise—and in Beauseant Commandery No. 11, K. T., by bestowal upon him of the highest office in its gift.

Sir Farrar served all the bodies in which he was called to labor with fidelity, and until his health failed, with energy, and leaves behind him an unblemished record as a Mason and citizen.

We recommend that a memorial page be set apart for each of the Em. Sir Knights mentioned»³.

In the detailed lists for the same year, we can trace the membership changes of the commandery, but some of the data are questionable. For example, George G. Avise appears simultaneously in three lists—among the Reinstated, the Dimitted, and the Suspended⁴.

In 1890, the commandery’s membership declined to 50 members. During the year, two Knights were Created, three Dimitted, and one Deceased⁵.




Fig. 4. In memory of Rev. Freeman D. Rickerson³




Fig. 5. In memory of Past Eminent Commander Thomas White ⁶




Fig. 6. Letter from the Recorder of Beauseant Commandery No. 11, T. J. Mackoy, to C. M. Ertel¹.

The list of officers was no longer provided in the report.

Created: Edwin G. Thompson, William F. Wehmeyer. Dimitted: Eli H. Wilkins, Henry Bretherick. Suspended: Walter Ogden, Charles E. Soule⁶.

Dead: William Somerville (Jan. 9, 1911)⁷.

In 1911, the members of Beauseant Commandery No. 11 and El Aksa Commandery No. 55 submitted a petition to merge the two commanderies in the city of Quincy. The petition specifically noted: «REPORT—Committee on Charters and Dispensations.

Sir Knight Holman G. Purinton, P.G.C., submitted the report of the Committee on Charters and Dispensations. It was adopted.

To the Grand Commandery of Knights Templar of Illinois:

Your Committee on Charters and Dispensations has had placed before it for its consideration a petition for a charter for a Commandery to be located at Quincy, Illinois, to be known as Quincy Commandery. It is in regular form and signed by 135 Sir Knights, of whom fifty are members of Beauseant Commandery No. 11, and eighty-one are members of El-Aksa Commandery No. 55, and four dimitted Sir Knights. Accompanying this petition are four dimits and 131 receipts for dues, and conditional dimits for same. The petition is in pursuance of a proposed consolidation of the two Commanderies mentioned, both of which are located at Quincy, Illinois, all of which is set forth in duly authenticated copies of resolutions adopted by said Commanderies agreeing to surrender the charters now held by them, and to turn over all property and

obligations now held by them to the new Commandery. After carefully considering this petition we recommend:

First — That a charter for a Commandery be granted the petitioners, to be known as Quincy Commandery No. 77.

Second — That in view of the fact that Beauseant Commandery No. 11 and El-Aksa Commandery No. 55 each having previously paid their charter fees, that the charter fee for the new Commandery be remitted.

Third — That the properties and obligations of the existing Commanderies be vested in and assumed by Quincy Commandery, and

Fourth — That the surrender of the charters of Beauseant Commandery No. 11 and El-Aksa Commandery No. 55, and the transfer of their properties take place at the time Quincy Commandery No. 77 is constituted»¹.

In 1912, neither Beauseant Commandery No. 11 nor El Aksa Commandery No. 55 existed in the Grand Commandery of Illinois; instead, Quincy Commandery No. 77 was established, with a total of 134 Knights². However, it should be noted that as early as December 7, 1921, an initiative group of Knights Templar from the city of Carbondale petitioned the Grand Commandery of Illinois for a charter to establish a new commandery under the name Beauseant, and in 1922 Beauseant Commandery No. 86 was established in the state of Illinois³.

Let us now summarize some conclusions. In Table 3, we compiled data on the members of Beauseant Commandery No. 11 for the period from 1861 to 1911, indicating changes in their status within the commandery. If no entry follows the date of joining the commandery, it means that the Knight continued to serve as of 1911.

According to Table 3, a total of 279 individuals passed through Beauseant Commandery No. 11 between 1861 and 1911. It was not uncommon for Masons to join the commandery as entire families. For example, the Brown family had five members, the Harris and Wood families had four members each, and the Avise, Smith, and White families had three members each.

In 1911, the oldest member of the organization was Charles Nathaniel Lee, who had joined the commandery in 1865 and held the record for longest service. Among deceased members, the longest-serving was Sir Joseph Robbins, who served from 1864 to 1909 (45 years); second was Sir William Somerville, from 1872 to 1911 (39 years); and third was Sir David G. Williams, from 1868 to 1905 (37 years).

Statistical data on membership changes over the 50-year period are presented in Table 4.


Analyzing Table 4, we can observe a slight discrepancy with Table 3. In Table 3, there are 279 names, whereas in the Created and Admitted columns of Table 4, there are only 276 names. In our view, this difference is due to the considerable number of variations in the spelling of members' names. We encountered up to four different spellings of the same last name, and there may also have been inconsistencies in the reports.

During the period from 1861 to 1911, 25 Knights Suspended their membership, 10 of whom were later Reinstated. 63 members died while still belonging to Beauseant Commandery No. 11. The number of members who Dimitted is also noteworthy, accounting for nearly half (46%) of the total membership—128 out of 276.

The data from Table 4 allowed us to compile information for a visualization of the membership of Beauseant Commandery No. 11 during the period from 1861 to 1911. For convenience, these data are presented in Chart 1.

¹ The report noted that in the previous year, 1883, the commandery had 71 members, while the report for 1882 indicated 72 members.

In Chart 1, we can see that the maximum membership of Beauseant Commandery No. 11 was in 1876; after that, the numbers declined. The reasons for this decline include:

Low membership in Chapter No. 5 (Quincy) and Chapter No. 157 (Mendon). Candidates for membership in Beauseant Commandery No. 11 came from these organizations, and their potential was limited.

The establishment of another commandery, El Aksa Commandery No. 55, in Quincy in 1882.

After the founding of El Aksa Commandery No. 55, some members of Beauseant Commandery No. 11 immediately transferred to the new commandery, and the already limited potential of the Chapters was now split between two commanderies, which negatively affected membership numbers. As a result, Beauseant Commandery No. 11 fell into stagnation and only emerged from it in 1912, when the two commanderies merged to form Quincy Commandery No. 77.

We also present brief biographical data on the members of Beauseant Commandery No. 11 who remained in the organization at the time of their death. This list is compiled in alphabetical order.

Adamy, Joseph Carl (Dec., 1834 – Nov. 2, 1893)



Joseph Carl Adamy was born on December, 1834, in Germany.
He was married to Caroline Wilhelmine Adamy.
He joined Beauseant Commandery No. 11 in 1884. He did not hold any officer positions.
He died on November 2, 1893.

Beard, James Ayers (1835 – Nov. 2, 1881)

James Ayers Beard was born in 1835, in Pennsylvania.
He was married to Catherine Beard.
He was a Civil War veteran who served in the 40th Illinois Infantry Regiment.
He joined Beauseant Commandery No. 11 in 1874. He did not hold any officer positions.
He died on November 2, 1881.

Beebe, Albert (Jul. 18, 1834 – Oct. 5, 1879)

Albert Beebe was born on Jul. 18, 1834, in Fall Creek, Adams County, Illinois.
He was married twice. His first wife was Aurelia Panama Beebe Nance, and his second wife was Anna Beebe.
He joined Beauseant Commandery No. 11 in 1873. He did not hold any officer positions.
He died on October 5, 1879.

Blakesley, Asa Wellington (Apr. 21, 1818 – Mar. 30, 1899)
(Past Commander)

Asa Wellington Blakesley was born on April 21, 1818, in Madison County, New York.
He was married to Mary Blakesley.
He joined Beauseant Commandery No. 11 in 1861 and was one of its founding members. That same year he was elected Prelate, a position in which he served until 1863. In 1864 he was elected Generalissimo, and in 1865 he rose to the highest office in the commandery—Eminent Commander—serving in that capacity for five consecutive years, until 1869. From 1870 onward he held the rank of Past Commander.

In 1870 he was elected Grand Warden in the Grand Commandery of Illinois. This was followed by a series of annual appointments: Grand Sword Bearer in 1871, Grand Standard Bearer in 1872, and Grand Senior Warden in 1873–1874. After 1874 he no longer held offices in the Grand Commandery of Illinois.

After completing his service at the grand level, he returned to active officer duties in his home commandery. In 1876 he was elected Captain of the Guards. He was again elected to this office in 1889 and 1892. After 1893 he no longer held officer positions.

He died on October 5, 1899.

Boyer, Noah (Mar. 8, 1840 – Jan. 1, 1888)

Noah Boyer was born on Mar. 8, 1840, in Fairfield County, Ohio.

He joined Beauseant Commandery No. 11 in 1883. He did not hold any officer positions.

He died on January 1, 1888.

Brown, Bernard (Dec. 18, 1837 – Jul. 24, 1897)



Bernard Brown was born on December 18, 1837, in Northern Ireland.

He was married to Mary Ann Brown and served as a police officer in Quincy, Illinois.

He joined Beauseant Commandery No. 11 in 1890. In 1892 he was elected Senior Warden, and in 1895 he became Captain of the Guards.

He died on July 24, 1897.

Brown, Henry Shafer (1827 – Dec. 24, 1882)

Henry Shafer Brown was born in 1827, in New York.

He was married to Nancy Brown.

He joined Beauseant Commandery No. 11 in 1869. In 1870, he was elected to the officer's position of Sword Bearer.

He died on Dec. 24, 1882.

Cahill, James B. (Jul. 21, 1838 – Jan. 9, 1874)



James B. Cahill was born on July 21 1838, in Utica, Oneida County, New York.

He was married to Ellen Maude Cahil.

He was a Civil War veteran. He served in the 16th Regiment Illinois Infantry, holding the rank of Captain, and later was promoted to Lieutenant Colonel.

He joined Beauseant Commandery No. 11 in 1871. He did not hold any officer positions.

He dead on January 9, 1874.

Carr, Gideon Vary (Mar. 15, 1821 – Apr. 21, 1865)

Gideon Vary Carr was born on March 15, 1821, in Sheldon, Wyoming County, New York.

During the Civil War, he served in the 146th Illinois Infantry Regiment as a 1st Lieutenant.

He joined Beauseant Commandery No. 11 in 1865 and did not hold any officer positions.

Gideon V. Carr died on April 21, 1865.

Carter, Thomas (Mar. 1, 1802 – Jun. 25, 1877)

Thomas Carter was born on March 1 1802, in Kentucky.

He was married to Elizabeth Carter.

He joined Beauseant Commandery No. 11 in 1862. In 1863, he was elected to the officer position of Standard Bearer. He did not hold any other positions.

He dead on June 25, 1877.

Colburn, Walter Newton (1829 - Feb. 16, 1883)

Walter N. Colburn was born in 1829, in Washington DC.

He was married to Sarah Ann Colburn.

He joined Beauseant Commandery No. 11 in 1870. In 1871 and 1872, he was elected to the officer position of Prelate.

He dead on February 16, 1883.

Demaree, Albert (Aug. 21, 1836 – Jul. 15, 1899)
(Past Commander)

Albert Demaree was born on August 21 1836, in Stark County, Ohio.

He was married to Adaline Demaree.

He joined Beauseant Commandery No. 11 in 1868. In 1870, he was elected to the officer position of Captain General. In 1871 and 1872, he held the office of Generalissimo. In 1873, he became Eminent Commander, a position he also held in 1874. In 1875, he assumed the rank of Past Commander and again held the office of Generalissimo. In 1878, he was elected Recorder, in 1880 Captain General, and in 1892, Sword Bearer.

He dead on July 15, 1899.

Dussair, James Paul (Jun. 30, 1871 – Jan. 5, 1910)
(Past Commander)

James Paul Dussair was born on January 30, 1871, Shelbyville, Shelby County, Missouri.

He was married to Catherine C. Murphy.

He joined Beauseant Commandery No. 11 in 1897. In 1898, he was elected to the officer position of Junior Warden, and in 1901, Generalissimo. In 1902, he became Eminent Commander. From 1903, he held the rank of Past Commander.

He dead on January 5, 1910.

Farrar, Isaac Newton (Apr. 10, 1836 – Aug. 7, 1889)
(Past Commander)

Isaac Newton Farrar was born on April 10 1836, in Troy, Rensselaer County, New York.

He was married to Elizabeth J. Farrar.

He joined Beauseant Commandery No. 11 in 1879. In 1883, he was elected to the officer position of Generalissimo, and in 1884, he assumed the highest office of Commander. From 1886, he held the rank of Past Commander.

He dead on August 7, 1889.

Freeman, Jordan Lewis (Oct. 1, 1808 – Jun. 7, 1882)

Jordan Lewis Freeman was born on Oct. 1, 1808,

He was married to Sarah Freeman.

He joined Beauseant Commandery No. 11 in 1866. He did not hold any officer positions.

He dead on Jun. 7, 1882.

Fuller, George (1842 – Apr. 3, 1896)

George Fuller was born in 1842, in Vermont.

He worked as an engineer.

He joined Beauseant Commandery No. 11 in 1885. He did not hold any officer positions.

He dead on April 3, 1896.

Goodrich, Robert E. (May 8, 1820 – Jul. 15, 1877)

Robert E. Goodrich was born on May 8, 1820, in Massachusetts.

He was married to Harriet Goodrich.

He joined Beauseant Commandery No. 11 in 1861 and was one of its founding members. In 1861, he was elected Captain General, and in 1862, Generalissimo. In 1867, he was elected Standard Bearer, and in 1868, again Generalissimo. In 1871, he became Junior Warden, and in 1872, Senior Warden.

He dead on July 15, 1877.

Harris, John R. (1841 – May 15, 1876)

John R. Harris was born in 1841.
He was married to Mary F. Craver.
He joined Beauseant Commandery No. 11 in 1864. He did not hold any officer positions.
He dead on May 15, 1876.

Heidemann, John William (Jan. 15, 1843 – Jun. 1, 1906)

John William Heidemann was born on January 15, 1843, in Germany.
He was married to Juliana Heidemann.
He was a Civil War veteran.
He joined Beauseant Commandery No. 11 in 1872. He did not hold any officer positions.
He dead on June 1, 1906.

Hoar, Benjamin Forman (Apr. 11, 1824 – Oct. 27, 1884)

Benjamin Forman Hoar was born on April 11, 1824, in Lancaster, Lancaster County, Pennsylvania.
He was married to Lydia Hoar.
He joined Beauseant Commandery No. 11 in 1868. In 1869, he was elected Senior Warden. He held the office of Senior Warden again in 1871, Captain General in 1872, Generalissimo in 1873, and again Generalissimo in 1876.
He dead on October 27, 1884.

Johnston, Frederick G. (Apr. 5, 1815 – Aug. 11, 1880)

Frederick G. Johnston was born on April 5, 1815,
He was married to Sally Ann Johnston.
He joined Beauseant Commandery No. 11 in 1864. He did not hold any officer positions.
He dead on August 11, 1880.

Jones, John Paul (Oct. 14, 1795 – Nov. 13, 1868)

John Paul Jones was born on October 14, 1795, in Sutton, Merrimack County, New Hampshire.
He was married to Polly Wells Jones.
He joined Beauseant Commandery No. 11 in 1863. In 1864, he was elected Captain of the Guards, and he held this position in 1865 and 1866 as well.
He dead on November 13, 1868.

Lambert, John H. (Oct. 8, 1836 – Jul. 2, 1868)

John H. Lambert was born on October 8, 1836, in Virginia.
He joined Beauseant Commandery No. 11 in 1866. In 1868, he was elected Senior Warden.
He dead on July 2, 1868.

Lambert, Rodney (Nov. 15, 1832 – Sep. 23, 1886)

Rodney Lambert was born on November 15, 1832, in Frederick, Frederick County, Maryland
He was married to Martha Isabel Wolfe.
He joined Beauseant Commandery No. 11 in 1866. He did not hold any officer positions.
He dead on September 23, 1886.

Larkworthy, William Balkwill (Oct. 1, 1827 – Jun. 19, 1890)

William Balkwill Larkworthy was born on Oct. 1, 1827, in England.

He was married to Ann Larkworthy.

He joined Beauseant Commandery No. 11 in 1868. In 1871, he was elected to the officer position of Standard Bearer.

He dead on June 19, 1890.

McCormick, James Freeman (1840 – Sep. 24, 1874)

James Freeman McCormick was born in 1840, in Pennsylvania.

He was married to Jane McCormick.

He joined Beauseant Commandery No. 11 in 1870. He did not hold any officer positions.

He dead on September 24, 1874.

McVay, Michael (1815 – May. 2, 1893)

Michael McVay was born in 1815, in Ireland.

He was married to Charlotte McVay.

He joined Beauseant Commandery No. 11 in 1861 and was one of its founding members. In 1883, he was elected Captain of the Guards, a position he held again in 1886.

He dead on May 2, 1893.

Mead, Charles W. (1836 – June 17, 1894)

Charles W. Mead was born in 1836, in Illinois.

He was a Civil War veteran. During the war, he commanded the Quincy Mounted Guards and held the rank of Captain.

He joined Beauseant Commandery No. 11 in 1861 and was one of its founding members. In 1861, he was elected Senior Warden; in 1862, Captain General; in 1863, Generalissimo; in 1864 and 1865, Captain General again.

He dead on June 17, 1894.

Mellen, John (Aug. 1, 1785 – Apr. 1, 1871)

John Mellen was born on August 1, 1785, in Pelham, Hampshire, Massachusetts.

He was married to Sarah Mellen.

He joined Beauseant Commandery No. 11 in 1861 and was one of its founding members. In 1861, he was elected Treasurer, a position he held until his death.

He dead on April 1, 1871.

Menke, Frederick William (Dec. 11, 1858 – Jun. 18, 1908)

Frederick William Menke was born on December 11, 1858, in Illinois.

He was married to Josephine Menke.

He joined Beauseant Commandery No. 11 in 1871. He did not hold any officer positions.

He dead on June 18, 1908.

Dr. Morris, George (Aug. 1, 1839 – Feb. 6, 1879)



George Morris was born on August 1, 1839, in Payson Township, Adams County, Illinois. He joined Beauseant Commandery No. 11 in 1868. He did not hold any officer positions. He died on February 6, 1879.

Neal, Thomas (birth date unknown – Mar. 12, 1866)

Thomas Neal (date and place of birth unknown). He joined Beauseant Commandery No. 11 in 1861 and was one of its founding members. He did not hold any officer positions. He died on March 12, 1866.

Newton, Milton W. (Oct. 31, 1837 – Feb. 21, 1879)

Milton W. Newton was born on October 31, 1837, in Wayne County, Ohio. He was married to Emma M. Newton. He joined Beauseant Commandery No. 11 in 1869. He did not hold any officer positions. He died on February 21, 1879.

Oven, William Eckley (Aug. 27, 1831 – May 5, 1891)
(Past Commander)

William Eckley Oven was born on August 27, 1831, in England. He was married to Martha A. Oven. He joined Beauseant Commandery No. 11 in 1861 and was one of its founding members. In 1861, he was elected Generalissimo. In 1862, he was elected Commander, a position he held in 1863 and 1864. From 1865, he became Past Commander. In the same year, he was elected Prelate in the Commandery and Grand Junior Warden in the Grand Commandery of Illinois. In 1866, he was elected Captain General in the Commandery while continuing as Grand Junior Warden in the Grand Commandery. In 1867, he remained Captain General in the Commandery and was elected Grand Captain General in the Grand Commandery of Illinois. From 1868, he did not hold any further officer positions. He died on May 5, 1891.

Pfeiffer, George Reinbeck (Charles) (Apr. 7, 1826 – May 30, 1897)

George Reinbeck Pfeiffer was born on April 7, 1826, in Germany.
He was married to Christina Carolina Wessels.
He joined Beauseant Commandery No. 11 in 1884. He did not hold any officer positions.
He died on May 30, 1897.

Pool, Levi Andrew (Apr. 1, 1855 – Jan. 25, 1907)
(Past Commander)

Levi Andrew Pool was born on April 1, 1855, in Quincy, Adams County, Illinois.
He was married to Mary B. Pool.
He joined Beauseant Commandery No. 11 in 1894. In 1895, he was elected Warder; in 1898, Generalissimo; in 1900, Commander. From 1901, he served as Past Commander.
He died on January 25, 1907.

Dr. Rittler, Frederick Wilhelm Johannes (Dec. 27, 1828 – Apr. 1, 1892)



Frederick Wilhelm Johannes Rittler was born on December 27, 1828, in Germany.
He was married to Ida Emelie Rittler.
He joined Beauseant Commandery No. 11 in 1883. He did not hold any officer positions.
He died on April 1, 1892.

Dr. Robbins, Joseph (Sep. 12, 1834 – Jul. 19, 1909)
(Past Commander)



Joseph Robbins was born on September 12, 1834, in Worcester, Worcester County, Massachusetts.

He was married to Julia D. Robbins.

He joined Beauseant Commandery No. 11 in 1864. In the same year, he was elected Warder. In 1865, he became Junior Warden; in 1866, Prelate, holding this office also in 1867, 1868, and 1869. In 1870, he was elected Commander, a position he retained in 1872. From 1873, he served as Past Commander. In 1882, he was elected Captain General. He served in the Commandery for 45 years, the longest tenure of any member.

He died on July 19, 1909.

Roth, John A. (Apr. 11, 1814 – Oct. 1, 1875)

John A. Roth was born on April 11, 1814, in Bavaria.

He was married to Appolonia Roth.

He joined Beauseant Commandery No. 11 in 1864. He did not hold any officer positions.

He died on Oct. 1, 1875.

Rutherford, George Valentine (1830 – Aug. 26, 1876)



George Valentine Rutherford was born in 1830, in Rutland, Vermont.

He was married to Lucy E. Keyes.

A Civil War veteran, he served as Colonel in the Quartermaster Department, USV, Union Army. From March 12, 1865, he held the rank of Brigadier General. He was a witness to the assassination of President Abraham Lincoln on April 14, 1865, and authored the first published account of the event. He joined Beauseant Commandery No. 11 in 1870 and did not hold any officer positions.

He died on August 26, 1876.

Schermerhorn, John Van Rensalier (Oct. 13, 1860 – Feb. 12, 1903)

John Van Rensalier Schermerhorn was born on October 13, 1860, in Quincy, Adams County, Illinois.

He joined Beauseant Commandery No. 11 in 1899. He did not hold any officer positions.

He died on February 12, 1903.

Seaver, Ira A. (Sep. 20, 1835 – Jul. 15, 1878)


Ira A. Seaver was born on September 20, 1835, in Washington, Vermont.

He was married to Eliza Herlemann.


He joined Beauseant Commandery No. 11 in 1876. He did not hold any officer positions.

He joined Beauseant Commandery No. 11 in 1868. He did not hold any officer positions.
He dead on March 9, 1876.

Skinner, Onias Childs (Jul. 22, 1817 – Feb. 4, 1877)

He was married to Sarah Skinner.
He joined Beauseant Commandery No. 11 in 1862. He did not hold any officer positions.
He dead on February 4, 1877.

Smith, William Jay (1840 – Dec. 6, 1907)

William Jay Smith was born in 1840, in Quincy, Adams County, Illinois.
He was married to Mary Schlenk.
He joined Beauseant Commandery No. 11 in 1883. He did not hold any officer positions.
He dead on December 6, 1907.

Somerville, William (Aug. 15, 1837 – Jan. 9, 1911)



William Somerville was born on August 15, 1837, in Pennsylvania.

He was married to Mary Josephine Thompson.

A Civil War veteran, he served in the 16th Regiment Illinois Infantry with the rank of Captain.

He joined Beauseant Commandery No. 11 in 1872. In 1873, he was elected to the officer position of Sword Bearer. He did not hold any other officer positions.

He died on January 9, 1911.

Steinagle, John (1816 – Mar. 22, 1872)

John Steinagle was born in 1816, in Hesse-Darmstadt.

He was married to Margareth Steinagel.

He joined Beauseant Commandery No. 11 in 1864. He did not hold any officer positions.

He died on March 22, 1872.

Summers, William Alexander (Feb. 21, 1827 – Jul. 16, 1900)
(Past Commander)

William Alexander Summers was born on February 21, 1827, in Maryland.

He was married to Anna Mary Ahalt.

He joined Beauseant Commandery No. 11 in 1876. In 1880, he was elected to the officer position of Prelate. He continued to hold this position in 1883 and 1886. In 1887, he was elected Commander, and from 1888 he held the title of Past Commander. In 1889, 1892, 1895, and 1898, he was again appointed Prelate. Most likely, he served in this position for about 20 years.

He died on Jul. 16, 1900.

Swope, Albert Fleming (Mar. 10, 1819 – Nov. 19, 1907)

Albert Fleming Swope was born on March 10, 1819, in Kentucky.

He was married to Caroline T. Swope.

He joined Beauseant Commandery No. 11 in 1896. He did not hold any officer positions.

He died November 19, 1907.

Taylor, Shubael O. (Dec. 19, 1838 – Aug. 10, 1876)

Shubael O. Taylor was born on December 19, 1838, in Malden, Middlesex County, Massachusetts. He joined Beauseant Commandery No. 11 in 1870. He did not hold any officer positions. He died August 10, 1876.

Thienemann, Johannes Anton (Jun. 24, 1833 – Aug. 15, 1874)

Johannes Anton Thienemann was born on June 24, 1833, in Germany. He was married to Luise Mohrmann. He joined Beauseant Commandery No. 11 in 1871. He did not hold any officer positions. He died on August 15, 1874.

Wallace, John W. (1835 – 1883)

John W. Wallace was born in 1835, in Tennessee. He was married to Johana Wallace. He joined Beauseant Commandery No. 11 in 1876. He did not hold any officer positions. He died in 1883.

Weber, Wendalin (Oct. 21, 1821 – Mar. 12, 1873)

Wendalin Weber was born on October 21, 1821, in Germany. He was married to Agatha Weber. He joined Beauseant Commandery No. 11 in 1865. He did not hold any officer positions. He died on March 12, 1873.

Wheat, Alexander Edwin (Apr. 19, 1833 – Sep. 3, 1885)

Alexander Edwin Wheat was born on April 19, 1833, in Venice, New York. He was married to Mary Josephine Woodruff. He joined Beauseant Commandery No. 11 in 1867. He did not hold any officer positions. He died on September 3, 1885.

Whitebread, John (Apr. 19, 1836 – Dec. 22, 1899)
(Past Commander)

John Whitebread was born on April 19, 1836, in Hollenback, Luzerne, Pennsylvania. He was married to Ravana Moyer. He joined Beauseant Commandery No. 11 in 1882. In 1886, he was elected to the officer position of Generalissimo. In 1888–1889, he served as Commander, and from 1890 he held the title of Past Commander. He died on December 22, 1899.

White, Thomas (Jan. 8, 1825 – Apr. 6, 1896)
(Past Commander)



Thomas White was born on January 8, 1825, in Scotland.

He was married to Mary Bowman.

He joined Beauseant Commandery No. 11 in 1872. In 1880, he was elected to the officer position of Generalissimo. In 1881, he became Commander, and in 1882 he was re-elected to this position. From 1883, he held the title of Past Commander. In 1886, he was elected Treasurer, and again in 1889, 1892, and 1895. He likely served as Treasurer for about 10 years.

He died on April 6, 1896.

Wiggins, Charles (birth date unknown – Dec. 16, 1907)

Charles Wiggins (place and date of birth unknown).

He joined Beauseant Commandery No. 11 in 1888. In 1892, he was elected to the officer position of Warder.

He died on December 16, 1907.

Williams, David G. (Dec. 3, 1837 – Sep. 11, 1904)

David G. Williams was born on December 3, 1837, in Columbiana, Columbiana, Ohio.

He joined Beauseant Commandery No. 11 in 1868. He did not hold any officer positions.

He died on December September 11, 1904.

In total, this list contains 60 brief biographies, including 10 biographies of Templar members who held the status of Past Commander. Among these members, the most notable was George Valentine Rutherford (1830–1876), a brigadier general during the Civil War and a witness to the assassination of President Abraham Lincoln.

Information regarding the officer corps of Beauseant Commandery No. 11 is of particular importance in this study. These details have been compiled in Tables 5–7.

From the data in Table 5, we can see that within this group of officers, the same individual was most frequently re-elected only to the office of Prelate. For example, William A. Summers was elected Prelate approximately 20 times. For all other officer positions, the same person typically held the office only twice.

From the data in Table 6, we can see that among this group of officers, there were two positions that the same person could hold repeatedly: Treasurer and Recorder. For example, Thomas J. Mackoy served as Recorder for over 20 years, and Thomas White held the office of Treasurer for about the same length of time. Officers in all other positions changed almost constantly.

From the data in Table 7, we can see that among this group of officers, the same individual could be re-elected multiple times (five or more) only to the office of Captain of the Guards.

Over the 50 years of the commandery's existence, there were a total of 29 Eminent Commanders. The majority of them—16 individuals—held the office for two or more years, while 13 served for only one year.

Unfortunately, during the research on the history of Beauseant Commandery No. 11, we did not find any photographs of the knights in their uniforms. As a result, we collected information on the uniforms of other commanderies within the Grand Commandery of Illinois during the late 19th and early 20th centuries. It is known that in Illinois, the Templars used the Regular Uniform of the Masonic Order of Knights Templar. We illustrate this point with a photograph from the parade at the 26th Triennial Conclave of the Knights Templar, which included, among other Illinois commanderies, St. Bernard Commandery No. 35 (Fig. 7).

In Fig. 6, we can see the regular white uniform without aprons. Using historical reconstruction methods, The Museum of the History of the American Knights Templar at Cherkas Global University recreated the uniform of Eminent Commander from Beauseant Commandery No. 11 (Figs. 8–11).

Thus, in conclusion, it should be noted that Beauseant Commandery No. 11 operated in Quincy for fifty years, from 1861 to 1911. During this time, no fewer than 279 individuals became affiliated with the commandery. Among them were several notable figures, including Brigadier General George Valentine Rutherford (1830–1876), a Civil War veteran and eyewitness to the assassination of President Abraham Lincoln. A number of Past Commanders of Beauseant Commandery also held officer positions within the Grand Commandery of Illinois, and in 1887, Past Commander Edward Starr Mulliner was elected Grand Commander.

Throughout its existence, the commandery experienced both periods of rapid development and phases of decline. Significant membership growth occurred during the first fifteen years, and by 1876, the commandery numbered 113 members. Subsequently, due to a variety of factors, membership stagnated and began to fall. Contributing causes included the establishment in 1882 of El Aksa Commandery No. 55 in the same city; the insufficiently developed network of local Chapters, which served as the principal source of new members for the Knights Templar; as well as additional contributing circumstances. As a result, by 1901, only one-third of the former membership remained—44 members.

A renewed period of growth began after 1901. In 1911, the members of Beauseant Commandery No. 11 and El Aksa Commandery No. 55, both located in Quincy, decided to unite and submitted a petition to that effect to the Grand Commandery of Illinois. As a result, in 1912 a new Knights Templar body—Quincy Commandery No. 77—was established in the city. With its creation, the history of Beauseant Commandery No. 11 came to a close.
